## TERMS AND CONDITIONS

### 1. INTERPRETATION

- 1.1 In this agreement, unless the context otherwise indicates:
- 1.1.1 "ACM" means **AC MOTORHOMES** of 31 Industria Road, Brackenfell, 7560
  - 1.1.2 "Customer" means the party agreeing to purchase the motorhome and the signatory to this contract and the signatory to the quotation given by ACM;
  - 1.1.3 "Motorhome" means the motorhome as chosen by the customer and detailed on the quotation;
  - 1.1.4 "Effective Date" means the date on which the customer accepts the quotation by signing it;
  - 1.1.5 "Supplementary statement" means any statement of account given by ACM to the customer for any price changes and/or other costs which may change during the contract due to price changes by supplier;
  - 1.1.6 "Contract" means the quotation, together with these terms and conditions and any supplementary statements forwarded to the customer from date of acceptance of the quotation;
  - 1.1.7 "Contract price" means all monies owed to ACM in terms of the quotation and supplementary statement given to the customer.
- 1.2 Words importing the singular shall include the plural and vice versa and words importing the masculine gender shall include females and words importing persons shall include partnerships and bodies corporate.
- 1.3 The head notes to the clauses in this agreement are inserted for reference purposes only and shall not affect the interpretation of any of the provisions to which they relate.

### 2. TERMS AND CONDITIONS

- 2.1 ACM shall provide the customer with a quotation. The customer understands that it is his duty to ensure that the quotation is correct and in line with his specifications before signing and accepting the same.
- 2.2 The deposit as described on the quotation is due within 7 (Seven) days of signature and is to be paid into the bank account of ACM, details of which are as follows: **ABSA, Cape Gate (632005), account number 4050546856**. All payments throughout the contract are to be made into this account.
- 2.3 ACM will advise the customer verbally and in writing of the date that the next progress payments are due and the customer agrees to pay the same within **48 hours** of being requested to do so.
- 2.4 In the event of the customer purchasing the chassis cab from ACM in terms of the quotation, ACM agrees to register the chassis cab into its MIB stock until such time as the customer is able to take delivery thereof.

- 2.5 In the event of the customer opting to purchase his own chassis cab, the customer agrees to deliver the chassis cab to ACM's premises so that ACM can build the motorhome section onto it.  
***All liability for the customer's chassis cab while on ACM's premises will remain with the customer. ACM shall not be responsible for any loss or damage caused to such chassis cab in the event of fire, theft or any other cause beyond its control.***
- 2.6 ACM agrees to register the motorhome into the customer's name upon completion of the motorhome by ACM and final payment of any outstanding balance by the customer.
- 2.7 Delivery of the motorhome to the customer will only take place once payment has been received in full by ACM of all monies as detailed in the contract as per the contract price.
- 2.8 In the event that the customer does not make payment of any of the progress payments as requested by ACM in clause 2.3 above, or the balance due in terms of the contract, ACM will have the right to cancel the contract and claim damages from the customer. ACM will, furthermore, have the right to sell any chassis cab owned by the customer to mitigate its losses.
- 2.9 The customer understands that the chassis cab and all parts and extras of the motorhome will remain the property of ACM until full payment of the contract price has been received by ACM.
- 2.10 ACM undertakes to exercise due care as can be reasonably expected to safeguard any chassis cab delivered to its premises by a customer.

### 3. GENERAL PROVISIONS

- 3.1 No alteration, cancellation, variation of, or addition hereto shall be of any force or effect unless reduced to writing and signed by all parties to this agreement or their duly authorized representatives.
- 3.2 This document, together with the quotation and any supplementary statements contains the entire agreement between the parties and no party shall be bound by any undertakings, representations, warranties, promises or the like not recorded herein.
- 3.3 No indulgence, leniency or extension of time which any party may grant or show to any other party, shall in any way prejudice such party or preclude them from exercising any of their rights in the future.
- 3.4 The parties agree to the jurisdiction of the Magistrate's Court in the event of any dispute.
- 3.5 It is specifically recorded that ACM shall retain a ***lien*** over the customer's property until such time as the full contract price is paid in full.
